

SIBLINGS HAD CHARGES IN OTHER KILLINGS

Tamara Marie Marshall, youngest of the four people charged Monday with **killing** six people **in** a drug house, comes from a family that doesn't start trouble but won't back away from it either, her brother said Monday.

The Marshalls have **had** more than their share. Marie, 18, is the fourth of the five children **in** the family to face a criminal homicide **charge** since 1986.

"We haven't been a violent family," said the brother, Hubert Marshall Jr., 23. "The type of family we've been is a strong, forward-moving family. We don't back down."

Marshall spoke Monday after being released from a cell at Detroit police headquarters. He said he **had** been held through the weekend and interrogated by detectives **in** connection with the six slayings on St. Aubin Street for which his sister was arrested.

"I'm p---ed off about it," he said. "I've been treated like I killed all those people. I've been arrested for that murder. All because a lady on the news said Marie and her brothers did it. That chick has never seen me before. She never seen my brothers. How could she say it was Marie and her brothers when she doesn't know who her brothers are?"

Marshall and his sister Mary, 24, are both free on bond awaiting trial on **charges** of second-degree murder **in** connection with a shooting last Dec. 28 that left one person dead and five wounded at the Afro-Dogs Motorcycle Club **in** the 8800 block of Hubbell.

"People think that I'm a straight-up killer now because I've been slandered," Marshall said. "They'll read me like a killer and try to take me out as soon as I walk up. **In** this Afro-Dog shooting, I didn't shoot nobody and my sister wasn't even there. I was with another woman who people thought was my sister. But how am I going to get a fair trial?"

Marshall's brother, Dwayne, 26, is **in** a Detroit halfway house, serving a 5- to 15-year sentence for manslaughter. He was convicted **in** 1986.

Their father, Hubert Marshall Sr., 43, said he and his wife, 41, also were held by police and questioned, for more than 10 hours beginning late Friday afternoon, about the St. Aubin **killings** . He said police damaged the home of another family member who lives near them on Foley during a weekend search **in** connection with the **killings** .

"A lot of people was hurt, and that's bad," the older Marshall said of the **killings** . But he said he, his wife, and another daughter, 8, **had** nothing to do with it.

Detroit police officials acknowledged that Marshall family members were brought **in** for questioning before Marie Marshall was arrested late Saturday. They said investigators **had** a warrant to search a relative's house that was Marie's last known address.

Homicide Inspector Gerald Stewart said that although Marie Marshall's relatives were interviewed, they were never charged with a crime **in** the St. Aubin **killings**.

Hubert Marshall Jr. said the family **had** survived some tough times **in** unfriendly neighborhoods, moving from Calvert to Braile before settling at their current home on Foley.

His attorney, Michael Bakaian, said the Afro-Dogs shoot-out "was a whole lot of people with guns and a lot of shooting."

Hubert Jr. and Mary Marshall are free after posting \$1,000 bond. That "reflects, I believe on the strength of case" against the Marshalls, Bakaian said.
