## FBI, CITY POLICE CAPTURE RAPE SUSPECT AFTER CHASE

A reputed enforcer for the Young Boys Inc. heroin trafficking ring, sought on a charge of raping a 14-year-old girl, led **FBI** agents and **police** on a high-speed car **chase** through northwest Detroit Thursday before being caught.

Farod Mallory, 20, of Rainbow Drive in Lathrup Village, was seen leaving his sister's home in the 15400 block of Plainview at 10:45 a.m. by an **FBI** agent who had the house under surveillance, said **FBI** Special Agent John Anthony.

"Mallory's been sought since March on a federal unlawful flight to avoid prosecution warrant for the Feb. 24 **rape** of a Detroit girl," Anthony said. "A co-defendant charged with Mallory already has been convicted and is awaiting sentencing."

Mallory, who Anthony said was accompanied by his 17-year-old girlfriend, got into a 1976 Chevrolet and drove a short distance before "he (recognized) our agent and took off."

The agent radioed for help and other agents and Detroit **police** cars joined the **chase**, "which reached speeds of more than 90 miles an hour," Anthony said.

**Police** and **FBI** agents set up a roadblock at Schoolcraft and Evergreen, but Mallory, speeding south on Evergreen, "swerved around it and narrowly missed hitting a **police** sergeant," Anthony said.

"At Joy Road, Mallory swerved into the northbound lanes," where he hit a car being driven by Francis Tomscik Jr., 48, of Detroit, Anthony said. "Mallory crawled out the passenger-side window and fled into an alley, but he was arrested about a block away."

Tomscik was in stable condition Thursday night at Oakwood Hospital in Dearborn, a spokesman said.

Mallory's girlfriend, Monica Rushton, 17, of the 16500 block of Trinity in northwest Detroit, "was pulling a loaded .357 magnum revolver from under the front seat" as a **police** officer arrested her, Anthony said.

Anthony said 60 packets of suspected narcotics were found in the car.

Mallory was charged last year in the machine-gun slayings of two Detroit men. The charges were dismissed when "witnesses either failed to appear or gave conflicting testimony," said a spokesman from the Wayne County Prosecutor's Office.

Mallory was scheduled to be arraigned on the **rape** charge today, **police** said. Charges of assaulting a federal officer also will be filed against Mallory, Anthony said.
