CENTER LINE MAN JAILED IN SLAYING OF TWO WOMEN BIKERS

A 28-year-old Center Line carpenter, who also is president of the **Forbidden Wheels Motorcycle Club**, was arrested Wednesday night for the murder of two women motorcyclists at the Wheels' clubhouse early Sunday.

Detroit and Center Line police arrested Paul Allen Dye, known as Rocky, at his home in the 8000 block of McKinley.

Recorder's Court Judge William Hathaway signed the arrest warrant late Wednesday afternoon. Dye will be arraigned in Recorder's Court today on two counts of murder and two counts of using a firearm in the commission of a felony, police said.

Dye is being held in Detroit in the slayings of Donna Bartels, 22, of Bradenton, Fla., and Glenda Collins, 27, who lived with her boyfriend on Plainview in northwest Detroit.

The women were shot in the head inside the clubhouse and their bodies dumped at the side of Lahser and Dolson in a secluded area near the Rouge River, police said. The bodies were discovered shortly before 7 a.m. Sunday.

They had been at Harold's Sky Club, a bar at 21322 Fenkell near Westbrook, until about 2:30 a.m. Sunday, police said.

Collins had quarreled with her boyfriend earlier in the evening because she refused to leave the bar with him, according to witnesses in the bar. Patrons of the bar said they ejected Collins' boyfriend, also a cyclist, after he threatened her. The boyfriend later was questioned and released, and police said he is not a suspect in the case.

POLICE WOULD not discuss a motive in the slayings.

Harold's, a bar frequented by motorcyclists, is about three blocks east of the Wheels' motorcycle club and about a mile north of the northern edge of Rouge Park, where the women's bodies were found.

Police say the double killing apparently was not connected to a pipe-bombing at the home of Patricia Schara, mother of former Forbidden Wheels' president William (Mr. Boo) Schara, about 3 a.m. Sunday.

Schara, who has been missing for about a year, is rumored to have left town with between \$8,000 and \$20,000 belonging to the Wheels and a federation of local motorcycle clubs he also headed.
