

## INQUIRY INTO CYCLE PROBE OF MOTORCYCLE CLUB URGED

A Detroit district judge Thursday called for a grand jury probe of a motorcycle club whose president has been charged in the slaying of two women inside the club's headquarters.

Judge William Hathaway made the suggestion after arraigning Paul Allen Dye, the president of the **Forbidden Wheels Motorcycle Club**, who was charged with two counts of first-degree murder Thursday for the slayings inside the Wheels' clubhouse Sunday.

"That we have an organization within our midst with such power and such loyalty that they can carry out an execution and others be ordered to cover it up leads me to believe we ought to have a Wayne County grand jury investigation of that club," Hathaway said..

According to documents based on police investigation and filed with the Detroit District Court, at least three other people were inside the club when the women were shot. All were members of the **Forbidden Wheels Motorcycle Club**, according to Dominick Carnovale, chief assistant Wayne County prosecutor

One witness saw Dye, 28, shoot the two women in the head at point-blank range with his 9mm Smith & Wesson semi-automatic handgun "for no apparent reason," the documents say.

DYE ORDERED the man and two others, who said they had been sleeping upstairs, to clean up the blood and brain tissue spattered around the clubhouse and dispose of the women's bodies, the documents say.

The bodies were dumped in a secluded spot at Lahser and Dolson, near the Rouge River at the north end of Rouge Park. They were found about 7 a.m. Sunday by a woman on her way to work.

"The motive for the killings is not clear," Carnovale said late Thursday. "Frankly, there may not have been a motive. It might just have been one of those weird things done by a weird person."

The victims were Donna Bartels, 22, of Bradenton, Fla., and Glenda Collins, 27, of the 14100 block of Plainview. They left Harold's Sky Club at Fenkell near Westbrook about 2:30 a.m., according to Howard Keech, a Sky Club bartender, and apparently went to the Forbidden Wheels clubhouse at 21607 Fenkell near Burgess, about three blocks away, where they had several drinks with Dye and others, court documents say. The women were standing at the bar inside the Wheels' clubhouse when Dye shot Collins, then Bartels, the documents say.

Dye entered no plea at the arraignment, so Hathaway entered a plea of innocent for Dye and ordered him held without bond in the Wayne County Jail pending his preliminary examination at 9 a.m. Sept. 14.
